- 3. The land parcel will be allotted on the basis of highest monthly license fee quoted in Rupees per SFT (excluding the applicable taxes). Corporation, reserves the right to negotiate further with the highest initial monthly license fee quoted bidder.
- 4. Tender document cost/Processing fee is Rs.11,800/- (Rs.10,000/- + Rs.1,800/- GST) (Non-refundable) and shall be paid through DD/Banker's Cheque drawn in favour of Telangana State Road Transport Corporation.
- 5. The EMD amount shall be paid through DD/Banker's Cheque drawn in favour of Telangana State Road Transport Corporation.
- 6. The EMD paid by the successful bidder shall be adjusted towards the initial Security Deposit payable and the successful bidder has to pay the difference of the amount which falls short of the Security deposit.
- 7. a) The Security Deposit (total 12 months of license fee), 6 months of initial monthly license fee shall be paid at the time of Handing over the site in the form of Demand Draft and the second installment equal to 6 months highest license fee (25th year license fee) in the form of Bank Guarantee with a validity of 5 years and shall be renewed for every five years, till completion of the contract period, the Bank Guarantee shall be submitted at the time of commencement of the business. - 12. **BID PARAMETER:** Highest monthly license fee quoted in Rupees per SFT excluding all applicable taxes (financial proposal/price bid) shall be the bid parameter for the selection of the bidder.
- 13. BID VALIDITY: The bid offered shall be valid for a period of 90 days from the date of opening of the bid.



14. BID PROCESS:

- a) Generally the selected bidder shall be the bidder offering the highest (H1) monthly license fee (excluding taxes, etc).
- b) H2 and H3 bidders shall be kept in reserve until the selected bidder H1 enters into lease agreement with Corporation.
- c) After opening of the tenders the EMD of all other unsuccessful bidders except H1, H2 & H3 will be returned.
- d) In case H1 bidder backs out from the bid process OR its bid is not selected / rejected for any reason duly foregoing the EMD, Corporation reserves right to invite and negotiate with the second highest bidder (H2) to offer revised bid higher than or match the quote of H1 bidder and allots the tender. If the tender was not allotted to H2 bidder also, Corporation will follow the same procedure in respect of H3 bidder. The EMD of unsuccessful bidder will be returned after entering agreement with the successful bidder or cancellation of tender process for any reason.
- e) After the completion of entering into lease agreement with the successful bidder, the EMD's of the unsuccessful bidders except H1 bidder will be returned.
- f) Mere participation in the bid does not confer any right to the bidder to claim the bid.
- g) Corporation reserves right to withdraw any of the locations from the tender process OR cancel the entire tender process at any stage without assigning any reason. In that case, the EMD will be returned to respective bidders.

15. ELIGIBILITY CRITERIA:

A. **TECHNICAL BIDS**; Only those Bidders who possess the following eligibility criteria shall apply. Bidders shall submit documentary proof of eligibility criteria. Bids which are not meeting eligibility criteria will be summarily rejected.

The eligible Bidder shall be Partnership firm / Proprietary firm/ Company / Real Estate Developing company/ Corporation established under the law of land and shall fulfill the following criteria.

- a) Technical Capacity:
 - For demonstrating technical capacity and experience (the "Technical Capacity"), the bidder shall meet the requirements set out below (the Threshold Technical Capacity")
 - Bidder should be a Corporate with at least 15 years of prior experience in India in the business quoted in this tender.
- b) Financial Capacity:
 - For demonstrating financial capacity in terms of turnover and net worth (the "Financial Capacity"), the bidder shall meet the requirements set out below (the Threshold Financial Capacity")
 - The minimum net worth of the bidder shall be mentioned in Annexure-I as on bid due date AND
 For the last three consecutive financial years, the average turnover shall be as per Annexure -I
 per year including the financial year 2023-24.

NOTE:

- 1. Net worth is the difference between the assets and liabilities of a business.
- 2. Bidder shall upload/submit documentary proof of the net worth and turnover (Proof of which shall be submitted by way of Audited Profit &Loss Account and Balance Sheet certified by authorized Chartered Accountant and Auditor's Certificate) along with copy of GST Registration.
- 3. Income Tax: The Bidder shall submit Income Tax proof in the form of certified copies of Income Tax Returns filed for the stipulated THREE financial years 2021-22, 2022-23 & 2023-24.
- 4. Bidder shall submit company's incorporation certificate/Registration certificate.



- B. The bidders meeting the eligibility criteria in TECHNICAL BID will only be eligible for the opening of COMMERCIAL BID.
- 16. LICENSE PERIOD: The license period shall be 25 years and extendable by 5(FIVE) years on mutual consent subject to satisfactory performance by the Licensee. The license period commences from the date specified in the allotment letter.

17. MONTHLY LICENSE FEE:

- a) The site will be handed over to the successful bidder duly issuing a allotment letter. The successful bidder has to get conversion of land use. Necessary assistance such as paying requisite fees to Government and supplying required documents shall be the scope of the Corporation. License fee holiday for a period of 6 months from date of handing over the site to the bidder.
- b) The site will be handed over to the successful bidder duly issuing Allotment letter, the bidder shall enter agreement with the Corporation within Three days of receipt of allotment letter.
- c) The monthly license fee is calculated for each calendar month. Accordingly, the monthly license fee along with applicable taxes shall be payable by 10th of every month in advance.
- d) Delay in payment of monthly license fee will attract penalty @ 24% per annum for each day of delay on the amount payable.
- e) The Licensee shall pay the monthly license fee to the Corporation, without any deductions. In other words, the amount agreed to be paid to the Corporation towards the lease shall be paid in toto.
- f) The license fee paid by the licensee on time shall be accounted in seriatim strictly in order of the months for which license fee is payable. The same principle shall be applied for accountal in case of payment of arrears duly adjusting for the in-default cumulative GST first, then the cumulative penal interest and other charges viz., electricity, water etc., and then the remaining balance amount towards the earliest month for which the licensee has fallen in-default and then the next earliest month for which the licensee has fallen in-default and so on in that order.
- 18. MONTHLY LICENSE FEE ENHANCEMENT: The monthly license fee enhancement will be 5% over previous year license fee will be effective after 2nd year from the date of handing over the site to the bidder.

19. ELECTRICITY, WATER CHARGES& GST:

- a) The Licensee shall make his/her own arrangements for Electrical and Water connections at their own cost for getting permission from the concerned authorities in the name of TGSRTC. The service connection charges and the consumption charges have to be borne by the Licensee.
- b) The Electricity/Water meters and other required equipment shall be procured and get them installed as per the mandatory provisions by the licensee at his/her own cost.
- c) If the Electricity/Water meters are not working, the licensee has to get it repaired/replaced immediately at his/her own cost.
- d) In case, Licensee is allowed to dig bore well with the prior approval of Corporation and purchase motor at his/her own cost, the electricity charges for the power consumed by the Bore well motor and maintenance of the same shall be borne by the licensee only.
- e) The Licensee shall pay the applicable GST as fixed by the Govt. from time to time (at present the GST is 18% (CGST-9% + SGST-9%)) along with the monthly license fee. Any delay in payment of GST will lead to interest and penalty as applicable.
- f) The Licensee shall submit documentary proof having paid the charges towards Electricity and Water of previous months bill, along with the monthly license fee payment.
- g) Any tampering or misuse of Electricity and Water connections if reported by the concerned authorities, the Licensee shall be responsible to attend to the observations of the authorities including the penalty payments if any. Corporation shall be indemnified to that extent.

20. TAXES & INSURANCE:

- 24. The Bidder/Representative of the bidder shall produce self-attested copy of valid Photo Identity Card (PAN Card/AADHAR/Voter Id/Driving License/ Passport).
- 25. During the opening of the bids, only those with the original Photo Identity Card will be allowed inside the Tender Hall.
- 26. a) Tender form has to be downloaded from e-Procurement notification: The bidder shall have to submit the tender form only for the business mentioned and sealed cover to be submitted and for any deviation the tender will be rejected duly forfeiting the EMD amount.
 - b) Location wise separate tender form is to be submitted by the bidders.
 - c) The interested parties may **inspect/visit** the site/premises before submitting the tender form.
 - d) In case of Partnership Firms/ Proprietary firm/ Companies/ Real Estate Developing companies/ Corporations/ etc., the authorized representative can submit the tender along with authorization letter.

- h. If the Demand Draft/ Banker's Cheque in original is not obtained and enclosed to the Tender form submitted physically.
- i. In case the application form is not filled up properly i.e. from Item No.1 to 12 of Tender form.
- j. When the EMD is less paid than what is stipulated in the tender notification.
- k. When the EMD is paid through other means i.e., in a manner other than what is stipulated in the Tender Notification.
- When the application form is submitted by a minor. However, in case the tender is submitted on behalf of a minor, necessary proof of guardianship shall be submitted, failing which tender will be rejected.
- m. When the successful bidder fails to enter into an agreement with the Corporation.
- n. Non enclosure of requisite documents.

31. SECURITY DEPOSIT & BANK GUARENTEE:

- a) The Security Deposit (total 12 months of license fee), 6 months of initial monthly license fee shall be paid at the time of Handing over the site in the form of Demand Draft and the second installment equal to 6 months highest license fee (25th year license fee) in the form of Bank Guarantee with a validity of 5 years and shall be renewed for every five years, till completion of the contract period, the Bank Guarantee shall be submitted at the time of commencement of the business. 33. APPROVALS/ PERMITS:

- b) If licensee intends to vacate the premises for whatever reasons before completion of minimum period of FIVE YEARS, the licensee has to pay the balance amount of license fee which falls short of the amount equivalent to the stipulated minimum period of FIVE YEARS.
- c) If the licensee clears the balance license fee amount for the left over minimum stipulated period, the Security deposit and Bank Guarantee will be refunded. In case the Licensee fails to pay the amount which falls short of the amount payable for FIVE YEARS, Corporation has the right to adjust the security deposit and Bank Guarantee towards the dues payable by the licensee and refund the balance deposit, if any. In the event of any further short fall even after adjustment of Security deposit & Bank guarantee, the Licensee shall make good the short fall within the prescribed time indicated by the Corporation.

35. TERMINATION OF LICENSE:

- a) The Corporation shall have the right to terminate the License and to forfeit the Security deposit and Bank Guarantee and to adjust the amount towards due amounts payable to the Corporation and the license is liable for termination with **one (01) month advance notice** on the following grounds:
 - i) If the licensee defaults in payment of license fee continuously for three months or three times in a calendar year.
 - ii) If the licensee fails to do the business (for which license is granted) for a continuous period of NINETY (90) days.
 - iii) If the licensee is found encroached on to the unauthorized area.
 - iv) If the licensee performs business other than the specified in tender notification or as recorded Page 14 of 21 SIGNATURE OF THE BIDDER

in the deed of license.

- v) If the licensee commits any fraudulent activities.
- vi) If the licensee is found doing or resorting to any unethical activities or indulging in moral turpitude.
- vii) In case of misbehavior/assault committed by the licensee, his/her representatives against the employees of the Corporation in the course of latters' duties.
- viii) If the licensee commits any breach of terms and conditions of license deed.
- ix) If any malpractices committed by the licensee at the time and during the tender process and the same at a later date.
- x) In case the contract is terminated, Corporation shall have the right to adjust the deposits (Security Deposit & Bank guarantee amount) towards all the dues payable to the Corporation including incidental financial losses that might arise on account of such premature termination and also to forfeit the balance of security deposit & Bank Guarantee amount.
- b) The agreement can be terminated by giving three months advance notice on either side. In such circumstances, the deposit which may remain to the credit of the licensee will be refunded after all the dues payable to the Corporation have been settled out of the deposit made by the Licensee. Corporation shall not be liable to pay any damages that the licensee may suffer on account of such termination. However, the licensee is permitted to exercise option only on completion of minimum stipulated period of FIVE YEARS.
- c) The Licensor shall have right to terminate the license. His decision in this regard shall be final.

36. **JURISDICTION**

In case of any dispute/claim out of this notification/agreement, it shall be subject to the jurisdiction of Hyderabad and Secunderabad only.

37. CALLING FRESH TENDERS/EXTENSION OF LICENSE PERIOD

Fresh tenders will be called 6 months before the completion of license period of the Licensee. Due to some administrative reasons, if the period of license is extended for a temporary period, the licensee shall enter into a supplementary agreement with the licensor duly paying the requisite stamp duty at the cost of the licensee.

Any alterations/modifications to the structure during the subsisting period of license shall be carried out by the licensee at their own cost, with prior permission/approval of the Corporation.
- 39. The licensee shall maintain the constructed and open premises in tidy condition.
- 40. No additions, alternations or modifications shall be carried out by the licensee without the prior permission/approval of the Corporation during the period of agreement.

41. The successful bidder will be allowed to commence the business upon satisfaction of other formalities like payment of Security deposit & Bank Guarantee, execution of agreement (Deed of License) failing which EMD/Security Deposit & Bank Guarantee paid will be forfeited besides cancelling the allotment letter/ deed of license.

42. SUB-LEASE:

- a) The Licensee shall not be permitted to sublease, mortgage, encumber or sale the whole or any part of the leased land parcel. However the Licensee is allowed to sub-lease the part or whole of the constructed/built up area, subject to the prior approval of Corporation.
- b) The sub-leased business shall have the same scope or allied scope of the business as specified in the land lease agreement and the sub-lease terms and conditions shall be co-terminus with the Land lease agreement conditions.
- c) The licensee shall be responsible for ensuring the sub-licensee/sub-licensees to carry out the approved business of sub-lease as per the terms and conditions of the License Deed.
- d) The sub-licensee/sub-licensees shall be allowed to utilize reasonably required open space also for the purpose of carrying out such sub-leased business to the convenience of the customers.

43. CHANGE OF NATURE OF BUSINESS:

The licensee has to do the same business which is mentioned in the tender notification and for which the license is issued. The representations for change of nature of business by the licensee will not be entertained. If the licensee is found doing business other than that stipulated in the deed of license, the license is liable for termination duly forfeiting the Security Deposit & Bank Guarantee.

44. NOMINATION OF LEGAL HEIRS IN THE EVENT OF DEATH OF LICENSEE:

- a) Transfer of license is not permitted.
- b) In the event of death of licensee, the license shall come to an end. However, the licensor may permit the Legal Heirs of the deceased licensee, upon satisfactory performance of the agreement by the licensee, to run the business on the same Terms & Conditions for the remaining period of license duly entering into a supplementary agreement on Rs.100/- Non-Judicial Stamp Paper purchased at the cost of licensee for the remaining period of license.
- 45. The licensee shall pay minimum wages to the Labour engaged by him/her at the rates not less than the minimum wages as notified by the State Government from time to time under Minimum Wages Act 1948, failing which the licensee will be given an opportunity to rectify the same. Even upon issuing TWO notices by the Corporation, if the licensee fails to rectify the same, the land lease agreement will be terminated.
- 46. The licensee shall hold the statutory labour license as mandated by the Government of Telangana to engage the labour to run the business.
- 47. The licensee has to pay compensation in case of any accident to the personnel employed by them and customers visiting the licensee during the course of business. The licensee is alone liable for workmen's compensation and any other statutory dues and Corporation is not liable for payment of any such amount and to that effect the licensee shall indemnify Corporation from all such liabilities.
- 48. The licensee shall not exhibit or permit any advertisement of any company/ products/service except with reference to the approved business in the premises.

49. COMPLAINTS AND SUGGESTIONS BOOK:

The licensee shall maintain a Suggestion & Complaint book at his/her establishment and to be made Page 16 of 21

available to the public on demand. The said suggestion book shall be produced to the officials of the Corporation at the time of inspection. The suggestions of the inspecting officials on the complaints be scrupulously and compulsorily followed and failure to follow the same shall entitle the licensor for termination of the license after giving One month advance notice. Any system better than the above stated is allowed with the prior approval of licensor.

- 50. The licensee shall make his/her own arrangements for procuring necessary equipment for carrying out his/her business.
- 51. All notices, consents, sanctions, directions and approvals referred to in this agreement or otherwise shall be given by the licensor to the licensee and vice versa in writing.
- 52. The licensor may constitute a committee from time to time with officials and non-officials as members thereof with power to inspect the premises and advise the licensee suitably.

53. STATUTORY PROVISIONS:

The licensee shall follow all the statutory provisions during the license period including extension period if any and the licensee alone is responsible for any kind of violation and resultant action by the Government authority. The corporation shall be indemnified in all such cases.

54. DAMAGES/COMPENSATION:

- i) The Corporation shall not be accountable for any loss that the licensee may suffer on account of any damage/theft, etc. caused to the premises or its allied infrastructure installed by the licensee.
- ii) Corporation is not liable for any damage or loss caused to the items/goods/furniture sustained by the licensee.
- iii) The loss/damage if any caused to the neighboring premises by the licensee or his/her representatives; the compensation shall be borne by the licensee.
- iv) The Corporation is not liable to pay any compensation in case of death or injury (simple/grievous) caused to any person engaged by the licensee in the course of working for the licensee in premises and to any customer of the licensee. The licensee shall be liable to bear all expenses and for payment of compensation in all such cases and shall indemnify the Corporation to that extent.
- 55. In all disputes and doubts or interpretation of the clauses or conditions applicable to the license or otherwise, the decision of the Corporation shall be final and binding on the licensee.
- 56. The licensee has to undertake white washing/painting of the premises once two years at his own cost.
- 57. Security deposit & Bank Guarantee is refundable on the expiry of the period of license and subject to due performance and fulfillment of agreement conditions.

58. **CONCLUSION OF AGREEMENT PERIOD:**

- a) On the expiry of the period of the license or on its termination, as the case may be, licensee shall deliver the premises in "as is where is" condition, intact, to the licensor at 17.00hrs on the last day of contract.
- b) In the event of the licensee failing to deliver the premises to the licensor, the licensor shall have right to take possession of the premises by putting his own lock and key to the said premises.
