- 7. If the rate quoted is less/more than the above will not be accepted in the tenders.

In case the amount offered is less than the amount mentioned in the Tender Notification for the above items it will be rejected, since the value of Contract amount includes the Minimum Wages, PF/ESI with profit Margin.
