The licensee shall maintain the Two(2) LED TV's provided in the lounge by the Corporation. It is the responsibility of the licensee to ensure that they are in working condition. Also it is the responsibility of the licensee to maintain the AC's in the lounge in working condition at his owned cost.</p> <p>10. The licensee shall provide Cable TV (i.e. Tata sky) connections to the above 02 LED TV's at his own cost duly paying monthly rental charges.</p> <p>11. The licensee shall play the cinemas (Not pirated) in the TV's through Pen Drive. The cinemas played must be changed thrice in a week at his own cost. The contractor shall obtain prior approval of the CRM/MGBS for playing the films etc..
