## TERMS AND CONDITIONS

- 1. LICENCE PERIOD & LICENCE FEE: The Licence period of stalls/ open spaces for 5 years and incase of two wheeler parking is only 4 years. The Licence fee payable is enhanced from 2<sup>nd</sup> year onwards as per instructions vide ED(A,M&P,AM), Letter No. C3/437(77-2)/2020-OPD(M&C), dt.21.04.2023 and No.C3/437(77)/2020-OPD(M&C), dt.30.08.2023 as follows:
  - a. Stalls/open spaces/Dormitories at Major, A class, B class and C class bus stations: The license fee shall be enhanced by 5%, 5%, 10%, 15% in 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> year of license over the license fee payable in 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> year of license respectively.
  - b. Canteens in Major, A class, B class Bus Stations: The license fee shall be enhanced by 5% in 2<sup>nd</sup> year, 10% in 3<sup>rd</sup> year and 15% in 4<sup>th</sup> and 5<sup>th</sup> years (block) over previous year license fee. Further, the license fee will be enhanced by 20% in 6<sup>th</sup> and 7<sup>th</sup> years (block) over 5<sup>th</sup> year, 25% over 7<sup>th</sup> year license fee for the next 3 years block period, i.e., 8<sup>th</sup>, 9<sup>th</sup> and 10<sup>th</sup> years, if the license period is extended.

c. Canteens at C class Bus Stations: The license fee shall be enhanced by 5%, 10%, 15% & 20% in 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> year, of licence over the licence fee payable in 1st, 2nd, 3rd, & 4th year of licence respectively.

d.Cycle/ Scooter Stands/Parking Space at Major, A class, B class & C class Bus Stations: The license fee shall be enhanced by 5% in 2<sup>nd</sup> year, 10% in 3<sup>rd</sup> year and 15% in 4th year of license over the license fee payable in 1st, 2nd and

3rd years respectively.

2. The prescribed Auction Tender Form and terms and conditions may be downloaded from TGSRTC website http://tgsrtc.telangana.gov.in(tenders) from 19 .10.2024 to \_06 .11.2024 and enclose tender form processing fee DD and EMD DD along with tender form.

- 4. The filled in Auction tender forms along with DDs (EMD and Processing fee) and other documents to be kept in a sealed cover and shall be submitted in the sealed Tender Box on 67.11.2024 in between 10.30 am to 02.00 pm at 2nd floor RM/RR Office, MGBS, Hyderabad. The Tender box will be opened on the same day i.e., 07.11.2024 at 3.00 pm in RM/RR's office Conference Hall, MGBS, Hyderabad.
- 5. Individual tender form has to be submitted for each stall /Canteen /Space/Scooter and Cycle stand and etc..
- 6. Auction Tender form duly signed in all pages and Terms and Conditions and other relevant documents mentioned below should be submitted.
  - a) Processing Fee DD & EMD DD as per Tender Notification (DD shall be drawn in only nationalized bank) otherwise tender form will rejected.
  - b) Tender form cost (MR) as per Tender Notification
  - c) Filled and signed Tender Form on each page.
  - d) Terms and Conditions must be signed.
  - e) Caste certificate Xerox for reserved stalls.
  - f) Aadhar card Xerox copy.
  - g) PAN card Xerox copy
  - h) GSTIN registration number Xerox copy.
  - i) The interested parties who apply for tenders may inspect the premises before submitting the Tender Form duly contacting the Depot Manager of the respective Depot.

- The bidder has to pay the Earnest Money Deposit (EMD) amount and Processing Fee DD as notified in the Auction Tender notification by way of Demand Draft in favour of "Dy.Chief Accounts Officer, T.G.S.R.T.C., Rangareddy" and DDs shall be submitted along with Tender form. Failure to enclose the DDs to the tender form will be rejected. The EMD amount shall not carry any interest.
- 8. In case the EMD paid by the Tenderer is less than what is stipulated or the EMD paid through other means i.e., in a manner other than the stipulated in the notification, the EMD shall be forfeited to the Corporation without any notice duly rejecting the tender application at the time of opening of tenders.
- 9. The EMD amount of unsuccessful bidders will be refunded after finalization of tenders without any interest.
- 10. The successful Auctioner must deposit Six months highest Monthly license fee + One month advance license fee+ one month GST & one month MC and stamp Duty @2% on average Monthly license fee for execution of agreement before commencement of business.
- 11. The successful APPLICANT (allottee) shall pay the GST as applicable from time to time (at present the GST is 18% CGST-9% + SGST-9%) on payment of monthly licence fee (quoted by the licensee) every month.
- 12. The successful APPLICANT (allottee) shall pay the Maintenance Charges @ Rs.1.50 per sft (maximum: Rs.4,000/-) for every month.
- 13. Bidders will not be permitted to withdraw at any time and the corporation will not be responsible for delay in finalization of bids due to reasons beyond its control viz court directions etc.
- 14. In regard to stalls earmarked for SC/ST/PEBC, the bidder has to submit Caste Certificate issued by Competent Revenue Authority.
- 15. The Tenderer should submit separate Auction tender form for each tender along with DD with requisite EMD. Otherwise the tender will be rejected.
- 16. The participants in the auction are required to make themselves fully conversant with the eligibility and terms and conditions of the auction. So that no ambiguity arises at a later date in this aspect.
- 17. "The Firms / Individuals who were earlier awarded licences for operation of Stalls / Canteens etc., in the Bus Stations of the Corporation, but defaulted in payment of licence fee for more 2 months as on date of submission of the tenders are not eligible to participate in the bids. The firms / individuals whose licences were terminated due to default in payment of licence fee of due to breach of other terms and conditions of the licence agreement are not eligible to participate in the bids."
