- 3 The Tender Form together with the Terms & Conditions along with specifications of space/stalls and Two/Four Wheeler stands etc, can be purchased from the concerned Depots on working days during office hours i.e. From 05-02-2025 to 19-02-2025 on payment of requisite tender application fee as furnished above.
- 4 Individual tender form has to be submitted for each stall/canteen/space /two/four wheeler parking spaces.
- 5 Tender Forms will be issued only on production of a self attested copy of valid photo Identity Proof of the Intending Tenderers (Aadhar etc.,)
- 6 Tender Forms duly filled in all respects and signed on each page and placed in a sealed cover mentioning stall No., the nature of the business and name of the Bus Station written in capital letters on top of the cover be dropped in the Tender Box kept at Regional Manager Office, Adilabad during the office hours from 10.30 to 14.00 hours on 20-2-2025 The sealed tenders will be opened on the same day at 15.00 hours by a Committee in the presence of the tenderers or their authorized representatives.
- 7 The successful tenders must deposit six highest monthly license fee plus one month advance license fee and stamp duty @ 2% on average annual license fee for execution of agreement before commencement of business.
- 8 In regard to stalls earmarked for exclusive ST and SC/ST/PEBC, the bidder has to submit Caste Certificate issued by competent revenue authority.
- 9 The interested parties/bidders may inspect/visit the premises before submitting the Tender Form.
- 10 The detailed "terms and conditions" relating to the tender will be supplied along with the tender form.
