3. The Tender form duly filling in all respects shall be placed in the Tender Box kept at Regional Managers office, Bus Station Complex, Nizamabad on 20.02.2025 from 10.30 to 14.00 hours. The Tenders will be opened at 15.00 hours on the same day in the presence of the Tenderers.
4. Finalization of Tenders will be by way of negotiation by the Tender Committee. The decision of the Tender Committee in that regard shall be final.
(a) Other things being equal, if more than one tenderer quote lowest minimum amount of monthly remuneration and found suitable by the Tender committee, the contract shall be allotted on the basis of LOTTERY.
5. Period of contract is two(2) years from the date of commencement, and extendable one(1) more year based on the satisfactory performance.

6. The EMD should be paid through a Demand Draft obtained in favour of "Accounts Officer, T.G.S.R.T.C., Nizamabad Region", payable at Nizamabad, as specified in the Tender Notice.
7. The cost of the Tender form is Rs,885/- (750+135 GST).
8. The interested parties/ Bidders may inspect/ visit the premises before submitting the Tender Form and tenderers are required to made themselves fully conversant with the eligibility & terms and conditions, so that no ambiguity arises at a later date in this respect.
9. The No.of buses will be increased or decreased during the contract period as per the requirement of Corporation, and the remuneration will be revised accordingly.
