- The Statement showing the description of items to be sold/services offered is kept at Annexure II.
- The EMD Amount shall be paid through DD/Banker's Cheque drawn in favour of Accounts Officer, TSRTC, Nalgonda Region, NALGONDA. The EMD amount will not carry any interest.

LICENCE PERIOD:

- a) Stalls/open spaces/Dormitories: The license period shall be (5) five years only.
- b) Canteens in Major/A/B class Bus stations: 5+5(Extended) yrs only.
- Canteens in C class Bus stations: The license period shall be (5) five years only.
- d) Two Wheeler/Four wheeler Parking Stands: (4) Four years only.

5. LICENSE FEE:

- The successful tenderer has to pay the licence fee, as quoted in the tenders per month exclusive of Electricity and Water charges, Maintenance charges, GST etc., and the same shall be paid in advance on or before 10th day of current month.
- The Licensee shall pay the licence fee to the Corporation, without any deductions including TDS as Corporation is exempted from TDS. In other words, the amount agreed to be paid to the Corporation towards the contract shall be paid in toto.

- Stalls/Open Spaces/Dormitories at Major, A, B & C class Bus stations: The license fee shall be enhanced by 5%, 5%, 10%, 15% in 2nd, 3rd, 4th, 5th year of license over the license fee payable in 1st, 2nd, 3rd & 4th year of license respectively.
- Canteens at MAJOR, A & B CLASS Bus stations: The license fee shall be enhanced by 5% in 2nd year, 10% in 3rd year and 15% in 4th & 5th years (block) over previous year license fee. Further, the license fee will be enhanced by 20% in 6th and 7th years (block) over 5th year, 25% over 7th year license fee for the next 3 years block period, i.e., 8th, 9th & 10th years, if the license period is extended.
- Canteens at C class Bus Stations: The license fee shall be enhanced by 5%, 10%, 15% & 20% in 2nd, 3nd, 4th, 5th year of license over the license fee payable in 1st, 2nd, 3rd & 4th year of license respectively.
- Two Wheeler/Four Wheeler Parking Stands at Major, A, B & C class Bus stations: The license fee shall be enhanced by 5% in 2nd year, 10% in 3rd year and 15% in 4th year of license over the license fee payable in 1st, 2nd and 3rd years respectively.

ELECTRICITY, WATER CHARGES, MAINTENANCE CHARGES & GST:

a) Supply of water and electricity to the licensee by the Corporation is subject to availability. The consumption charges shall be paid at the rates fixed by the Corporation from time to time. In case, water is not provided by the licensor, the licensee shall have to make his/her own arrangements for supply of OF THE REGIONAL water at his/her own cos

- b) The digital Electrical sub-meter and other required equipment shall be procured by the licensee at his/her own cost. The licensee shall bear the expenses of electrical wiring from the power point to the
- If the meter is not working, the licensee has to get it repaired immediately at his/her own cost.
- d) In case, licensee is allowed to dig Bore well at his/her own cost, the electricity charges for the power consumed by the Bore well motor and maintenance of the same shall be borne by the licensee only.
- The licensee shall pay the maintenance charges @ Rs.1.50 per sft. of space allotted per month(as fixed by the Corporation and communicated from time to time) subject to a maximum of Rs.4,000/-.
- The licensee shall pay the applicable GST as fixed by the Govt. from time to time (at present the GST is 18% (CGST-9% + SGST-9%) along with the License fee at the rate. Any delay in payment of GST will lead

17. MINIMUM PERIOD OF DOING BUSINESS:

The minimum period of doing business by the licensee of Stall shall be ONE YEAR from the date of commencement of agreement period. b)

If any licensee intends to vacate the premises for whatever reasons before completion of minimum period of ONE YEAR, the licensee has to pay the balance amount of license fee which falls short of the amount equivalent to the stipulated minimum period of ONE (01) year.

If the licensee clears the balance contract amount for the left over minimum stipulated period of one year, the security deposit will be refunded. In case the Licensee fails to pay the amount which falls short of the amount payable for one year, corporation has the right to adjust the security deposit towards the dues payable by the licensee and refund the balance deposit, if any. In the event of any further short fall even after adjustment of security deposit, the Licensee shall make good the short fall within the prescribed time indicated by the licensor.



18. SECURITY DEPOSIT:



- b) The security deposit shall not carry any interest.
- c) The Security deposit refundable only after completion of license period. Security deposit will not be adjusted towards the licence fee payable by the licensee during the licence period.
- d) Security Deposit is refundable within 30 days after expiry of the period of licence and subject to due performance and fulfillment of terms and conditions of this agreement and after adjustment of dues.
- e) The Security deposit is liable for forfeiture in the event of failure by the licensee to pay the license fee or termination of license for breach of any condition/conditions of license.

 - If the licensee is found doing or resorting to any unethical activities or indulging in moral
 - In case of mis-behaviour/assault committed by the licensee, his/her representatives against vii)
 - viii) If the licensee commits breach of any terms and conditions of contract.
 - ix) In case the contract is terminated, Corporation shall have the right to adjust the deposits (Security Deposit amount and Bank Guarantee) towards all the dues payable to the Corporation including incidental financial losses that might arise on account of such premature termination and also to forfeit the balance of deposit amount.
- The contract can be terminated by giving three months advance notice on either side. In such circumstances, the deposit which may remain to the credit of the license will be refunded after all the dues payable to the Corporation have been settled out of the deposit made by the Licensee. Corporation shall not be liable to pay any damages that the licensee may suffer on account of such
 - However, the licensee is permitted to exercise this option only on completion of minimum stipulated period of one year. Corporation reserves the right to terminate the contract any time during the contract period by giving 3 months advance notice to the Licensee.
 - The Licensor shall have right to terminate the license. His decision in this regard shall be final.

Any modifications, changes, alterations, repairs, if any required shall be undertaken by the licensee at his own cost with the prior permission of the DY.RM(M)/DM concerned and as per the drawings approved by Dy.EE(C)/NLG duly bringing it the notice of the RM(NLG).
- 25. Open space allotted has to be designed according to the specifications prescribed by the TSRTC. The licensee has to erect temporary structure i.e., Steel Modular Kiosk of size 8'x8' as at Annexure at his/her own cost with the prior approval of the licensor.
- 26. The stall at the said open space shall be constructed under the supervision of the Dy.EE(Civil)/NLG.
- 27. No additions, alternations or modifications shall be carried out by the licensee without the prior approval of the licensor during the period of contract.
- 28. The Licensee shall not be given permission for construction of pucca structures in the allotted open space during the period of contract.

29. CONFINEMENT TO THE AREA OF STALLS/SHOPS/OPEN SPACES/ CANTEENS:

- a) The licensee has to perform the business by confining to the extent of space allotted as mentioned in the tender notification or as recorded in the deed of licence. There should not be any encroachment of platforms, area of other stall/shop by licensee, under any circumstances.
- The corporation reserves right to reduce the area mentioned or change the allotted place if required.

CHANGE OF NATURE OF BUSINESS:

The licensee has to do the same business which is mentioned in the tender notification and for which licence is issued. The representations for change of nature of business by the licensee will not be entertained. If the licensee is found doing business in the Stall / Shop other than that stipulated in the deed of licence and if the licensee sells items other than those specified in the deed of licence, the transaction duly forfeiting the Security Deposit.

SIGNATURE OF THE API

NOMINATION OF LEGAL HEIRS IN THE EVENT OF DEATH OF LICENSEE:

In the event of death of licensee, the licence shall come to an end. If the licensee found encroaching the platforms more than three times in a calendar year, the licensee is liable for termination with 7 (seven) days advance notice.

- The licensor shall have the right to terminate the licence (contract) if in his opinion the quality of goods/services sold/rendered is not upto the standard/satisfactory besides forfeiting the Security Deposit.

- 3. However the commercial offer of the bidder will be the criteria for allotment once they qualify in the technical bid.
- If the highest tenderer backs out or does not take up the licence for whatsoever reasons, the Regional Tender Committee shall forfeit the EMD amount paid by the tenderer.
- The Regional Tender Committee shall negotiate with the second highest tenderer to increase the offer only when the highest tenderer backs out from taking up the licence. If second highest tenderer agrees to enhance the offer equivalent to the amount offered by the highest tenderer, or more, the tender committee shall allot the canteen to the second highest tenderer or otherwise call fresh tenders.

SECURITY DEPOSIT:

6. The licensee shall pay 7 months licence fee towards security deposit and one month advance licence fee within 15 days from the date of allotment letter. The licensee shall pay the difference of security deposit whenever there is increase in monthly licence fee.

BANK GUARANTEE:

- The licensee shall, for due and punctual performance of his/her obligations during the licence period, deliver to corporation, as a precondition to the execution of this Agreement, submitted bank guarantee for sum equivalent to six monthly installments of first year of contract with a validity of 1 year. The bank guarantee furnished is in addition to security deposit. The licensee has submitted bank Guarantee for an amount of Rs. validity. LICENCE FEE HOLIDAY FOR MAJOR, A AND B CLASS BUS STATIONS:

For canteens, to facilitate the licensee for providing good ambience, furniture etc. a licence fee holiday period of & months is given to the licensee from the date of entering into an agreement. However the licensee shall pay the monthly licence fee from the date of commencement of business or after completion of one month from the date of entering in to agreement, whichever is earlier.

9. DIVIDING THE CANTEENS INTO TWO SECTIONS:

- a). For Major class Bus Stations, the licensee shall divide the canteen into i) Premium and ii) Economy sections invariably
- b) For A class Bus stations, the licensee shall divide the canteen into i)Premium and ii) Economy sections as per demand and on the advise of RM concerned enabling the canteen available to all classes of passengers.
- In Premium section, the licensee shall provide and maintain high standards on par with other reputed hotels in the City/Town with regard to Furniture, Waiters, Toilets, Wash Room etc. at his/her own cost.
- The waiters shall wear uniform which shall be supplied by the licensee at his own cost.
 - In Economy section also the licensee shall provide quality food with reasonable rates, neat and tidy premises and other required facilities.


10. FEATURES OF CANTEENS:

The following features shall be maintained at the canteens by the licensee during the subsistence of licence period.

- The premises and surroundings of the canteen shall be kept in clean and tidy condition always and are subject to inspections by the officials of the licensor and the Municipal Authorities.
- The licensee shall renovate and decorate the canteen allotted for good ambience at his own cost. Any changes that he opts to do shall be done with prior approval of the RM concerned duly obtaining the opinion of Dy.EE(Civil) concerned.
- The licensee shall set up a hygienic and clean kitchen, and cleaning areas with ultra modern stainless steel kitchen equipment and steam cooking range.

d. Utensils:

- The licensee shall use all utensils of standard quality stainless steel make only for preparation and supply of food stuffs (glasses, plates, jugs, spoons and other kitchen ware).
- The licensee shall use brass/stainless steel water containers with lids for storage of drinking water.





- The licensee shall sell quality food and maintain the quality as per the standards communicated by the Telangana State Civil Supplies Corporation in the canteen. The quality of all food stuffs shall be same and uniform for both premium and economy sections. However, at premium section, the licensee shall supply extra side dishes like chutneys, pickles etc.
- Purified and safe drinking water shall be made available in all canteens of all types of Bus Stations.
- The price list with quantity of food items shall be exhibited in the canteen at a conspicuous place.
- The licensee shall not use husk or coal as fuel in the canteen. The licensee should use LPG or bio gas in the canteen as
- i. The licensee shall insure the canteen structures against fire/damage or any other natural calamities at his/her own cost.
- Floor of the canteen shall be regularly cleaned and swabbed with scented detergents.
- k. Furniture in the canteen shall be provided with decolom top which will be convenient for
- Drainage lines shall be cleaned regularly to prevent chocking of lines and emitting bad
- m. Used plates, glasses and other utensils shall be cleaned with hot water and detergent powder.
- Drinking water storage containers and all other utensils shall be cleaned every day before topping with fresh water.
- The licensee shall supply uniforms to the waiters and cleaners and also to ensure that they attend the duties in the uniforms regularly.
- The employees of the corporation shall be given 25% concession on the rates of food stuffs
- The licensee shall erect "Glow Sign Board" without any advertisements (each 2) to the canteen in uniform size in consultation with the Bus station Manager/Depot Manager. He can also put directional sign boards (not exceeding 4) at the locations and sizes as decided by RM for the convenience of passengers apart from improving his business.

11. CIVIL WORK TO BE TAKEN UP BY THE CORPORATION TO THE CANTEENS:

- a) Drainage pipe line with sufficient diameter to avoid over flow and easy maintenance and collection chambers with Washing Area to be provided with tiles.




