Termination of tender process

30.TGSRTC may terminate the tender process at any time and without assigning any reason. TGSRTC makes no commitments, express or implied, that this process will result in a business transaction with anyone.

GENERAL CONDITIONS OF THE CONTRACT

1. The Tender is for appointment of contractor for FREE supply of disposable Seat Head Rest Covers (for Lahari, Rajadhani, E-garuda, Garuda Plus, Super Luxury & Deluxe(Including hire) buses of the Corporation) duly procuring and printing pvt. Ads (on 70% of space) and TGSRTCinformation (on 30% of space) forfree and to pay monthly license fee to the Corporation.

Dimension of the Seat Head Rest Covers is 45 Cm X 100 Cm (width X Length)

AD SPACE: 450 (W) X 700 (H) mm

450 (W) X 300 (H) mm - for display of TGSRTCPublicity matter

2. DETAILS OF DISPOSABLE HEAD REST COVERS(drawing) at Annexure-II

- 3. The details of approximate no. of buses& Seats(Type wise) held at each Regionare shown at Annexure-III.
- 4. The tenderers may inspect the buses & seats physically at Bus depots to have a clear idea before submitting their tender.
- 5. The quality of the Disposable Head Rest Covers will be certified by CCOS before supply. The scheduled program for Procuring No. of Disposable Seat Head Rest Covers and their dispatch shall be followed as communicated by CCOS from time to time.
- 6. The advertising contractor shall obtain approval of theduly submitting a copy of the content of the advertisement specifying the subject matterbefore display.

The C T M(M&C) & BUSINESS HEADshall have the right to reject either whole or part of the content of the Advertisement, or to ask for modification if the advertisement is objectionable and against the interests of the Corporation/Govt./general public or not worthy for display.

Only after obtaining certification from the above Officers on quality of the material (cloth) and Advertisement content the contractor can start the printing.

- 7. No advertisement shall be displayed without prior approval of the Officer Concerned.
- 8. The size of the advertisement may be restricted to 15 cm X 30 cm (height X width) at back side and 30 cm X 30 cm (height X width) at front side duly printing Corporation's publicity matter at front side restricted to 15 cm X 30 cm (height X width).

9. PRINTING OF ADS:

Advertisements shall be printed on the specified area on the front and back side of Disposable Seat Head Rest Covers in any one color. The advertisement contractor shall pay licence fee to the Corporation for display of Ad content on the Seat Head Rest Cover.

10. SECURITY DEPOSIT:

The successful tenderer shall have to pay an amount equivalent to the six highest monthly installments (out of the five year contract) towards Security Deposit of contract within 15 days from the date of issue of allotment letter for the contract.

The Security Deposit shall be paid to the C T M(M&C) & BUSINESS HEAD, T.G.S.R.T.C., Musheerabad, HYD., through Demand Draft obtained from any Nationalized Bank/Scheduled Bank located in Telangana in favour of TELANGANA STATE ROAD TRANSPORT CORPORATION, payable at Hyderabad.

The Security Deposit will be refunded after one month from the date of completion of the contract period, after adjusting the dues, if any payable by the advertising contractor to the Corporation.

The Security Deposit will not be adjusted towards monthly installments payable by the advertising Contractor.

In case of termination of contract due to breach of Terms and Conditions of contract, Corporation shall have the right to adjust the Security Deposit paid by the Advertising contractor towards the dues payable to the Corporation and to forfeit the balance Security Deposit. The Security Deposit will not carry any interest.

11. **BANK GUARANTEE**:

The successful tenderer shall have to submit Bank Guarantee for an amount equivalent to six monthly installments of $\mathbf{1}^{\text{st}}$ year contract amount within 15 days from the date of allotment of the contract. The Bank Guarantee shall have validity for entire contract period.

The Bank Guarantee shall be furnished in addition to Security Deposit. **The Bank Guarantee will be returned after completion/termination of the contract period.**

The Corporation shall have the right to invoke the Bank Guarantee at any time and to adjust the realized amount towards the due amounts payable to the Corporation, if the Advertising contractor defaults in payment of monthly installment amount or penalty, or for breach of any Terms and Conditions of the agreement.

12. Failure to pay the Security Deposit/ furnish Bank Guarantee/ enter into agreement within the stipulated period, the Corporation shall have the right to cancel the allotment of contract and the EMD/ Security Deposit/ Bank Guarantee amount shall be liable for forfeiture.

13. PAYMENT OF CONTRACT AMOUNT:

The contract amount payable by the advertising contractor shall be paid as under: The advertising contractor shall pay each monthly installment amount in advance on or before 10thday of every month to the C T M (M&C) & BUSINESS HEAD, Musheerabad, Hyderabad through RTGS/Online payment/demand draft obtained in favour of Financial Adviser, TGSRTC, Musheerabad, Hyderabad payable at Hyderabad.

The Advertising Contractor shall pay the contract amount to the Corporation, without any deductions including TDS as the corporation is exempted from Income Tax under section 196 of IT act 1961. In other words, the amount agreed to be paid to the Corporation towards the contract shall be paid in Toto.

In the event of delay in payment of monthly license fee the Advertising contractor is liable to pay **penalty** for each day of delay beyond the due date @ 36% per annum on the amount payable in addition to the installment amount. This clause shall not prevent the Corporation from invoking Bank Guarantee and forfeiting the Security Deposit of the advertising Contractor.

- 14. The Contractor shall pay GST to the Corporation as per the rules in force and at the rate as fixed by the Government from time to time, on the contract amount payable to the Corporation, in addition to payment of contract amount as agreed to be paid to the Corporation.
- 15.If the advertising contractor fails to pay the monthly installments within stipulated period as per the terms & conditions of this agreement, or commits breach of any conditions of the agreement, the Corporation shall have the right to take any one or all the following actions
 - a) to order to stop printing and display of advertisements
 - b) to invoke the Bank Guarantee and to adjust the amount towards due amounts payable to the Corporation
 - c) to adjust the Security Deposit towards due amounts payable to the Corporation
 - d) to deface/remove advertisements displayed.
 - e) to terminate the contract.

In case contract is terminated, Corporation shall have the right to adjust the deposits (Security Deposit and Bank Guarantee amount) towards all the dues payable to the Corporation including incidental financial losses that might arise on account of such premature termination and also to forfeit the balance of deposit amount.

16. The advertising contractor shall carryout their business of display of advertisements for a **minimum period of one year** from the date of commencement of the contract.

In the event of the contractor seeking premature termination of contract within the stipulated one year period, the contractor has to pay the balance monthly installments for the left over period of minimum stipulated contract period.

If the contractor clears the balance contract amount for the left over minimum stipulated period of one year, the deposits (Security Deposit and Bank Guarantee) will be refunded. In case the contractor fails to pay the amount which falls short of the amount payable for one year, Corporation has the right to adjust the deposits paid by the contractor towards the dues payable by the contractor and to refund the balance deposits, if any. In the event of any further short fall even after adjustment of Security Deposits, the contractor shall make good the short fall within the prescribed time.

17. Corporation willgive its scheduled program as informed by Chief Controller of Stores as when and where to dispatch the printed Disposable Seat Head Rest Covers. The contractor shall abide by such scheduled program.

Corporation will not give any guarantee on usage of the Seat Head Rest Covers in respect of distribution / schedule of to a particular Depot / Region / Zone as specified by the Advt. contractor.

However, the Corporation will try to circulate the Disposable Seat Head Rest Covers as per the requirements of the Advt. contractor.

- 18. The contractor is allowed to print ads within the size of 30 cms x 30 cms on front side &15 cms x 30 cms on back side of seat head rest cover. No other space (inside / outside of buses) will be permitted for display of Ads other than Seat Head Rest Covers in (Lahari, Rajadhani, E-garuda, Garuda Plus, Super Luxury & Deluxe(Including hire)).
- 19. The Corporation shall have the right to transfer the bus/buses under operation of a Depot / Region / Zone to the Depots of same /any other Region / Zone as it may think fit and necessary and the advertising contractor shall have no right to demand for operation of any such bus/buses within a particular Depot /Region / Zone during the period of Contract.
- 20. The advertising contractor shall have no right to demand operation of any bus / buses with advertisements on any particular route / routes, area, timings etc. Due to operational exigencies, these buses may be deployed to other distant places during the weekends/ festival seasons/ whenever the situation arises. The advertising contractor neither objects for the same nor claim any revenue/ loss, etc.
- 21. Corporation reserves the right to appoint separate contractor / contractors for display of advertisements on other types of buseswhich are not included in this contract.
- 22. i) The Advertising Contractor shall have to obtain any certificate or permission or license
 - as may be necessary or required from the concerned authorities of Central Government / State Government / Local body for display of advertisements.
 - ii) The Advertising Contractor shall comply with all the rules and procedures as required in the local / within the territorial limits, in which the business is carried on and shall pay all the Taxes, fees or other sums payable to the local or any authorities for the purpose of carrying out the business of display of advertisements and there shall be no dues payable to any authority.
- 23. The Advertising Contractor shall not procure/ display any advertisements for printing which may offend decency, good morals or may promote ill will or hatred amongst any class or classes of the public. Corporation shall have the right to prohibit / reject such advertisements from printing and the advertising agent shall not have the right to claim for any loss or damages that he may suffer on account of such rejection or restriction. The contractor shall ensure that all norms of decency and social ethics are practiced for displaying the Advertisement content.
- 24. The Advertising Contractor shall not procure& display advertisements concerning Tobacco, Liquor, Alcoholic products Narcotics, Obscene material, Religious / Political and Election campaign slogans or any other product prohibited by the Corporation / Government from time to time.
- 25. The Corporation shall not be liable for any loss incurred by the advertising contractor to its Bankers, Financial institutions, customers, personnel engaged by the advertising contractor or any other person connected with the business of the advertising contractor.
- 26. The Advertising Contractor shall not procure any advertisements for printing beyond the date of expiry of the agreement.

27. The Advertising Contractor shall furnish information that may be required by the Corporation from time to time, connected with the procurement of advertisements.

Signature of the tenderer

- 28. The Advertising Contractor shall have to supply the Disposable Seat Head Rest Covers and also to pay the contract amount as agreed to be paid to the Corporation, irrespective of procurement / display of advertisements.
- 29. The advertising contractor shall not display advertisements of businesses competitors with TGSRTC in passenger transport and Cargo & Logistics, Tourism
- 30. The Corporation shall not be accountable for any loss or damage etc. that the advertising contractor may suffer on account of any advertisements printed / not printed for any reason.
- 31. In case advertisements are not displayed due to bundhs / agitations / other internal or external factors, for a particular period or periods the Corporation shall not be liable for any loss or damage caused to the advertising contractor.
- 32. The Advertising Contractor shall not appoint other firms / agencies / individuals as sub -contractors to carry out the business.
- 33. The contract can be terminated by giving three months advance notice on either side.

But the contractor has to carry out the business for a minimum period of one year as per the Clause 10. If the contractor seeks premature termination, immediately on completion of one year, he/she has to intimate (in writing) his / her intention to terminate the contract at the beginning of the fourth quarter (i.e. soon after completion of 9 months period) from the date of commencement of the contract, in the form of 3 months advance notice.

However, Corporation reserves the right to terminate the contact any time during the contract period, by giving 3 months advance notice to the contractor.

In such circumstances, the deposits which may remain to the credit of the contractor will be refunded after all the dues payable to the Corporation have been settled out of the deposits made by the Contractor (Security Deposit, Bank Guarantee etc.). Corporation shall not be liable to pay any damages that the contractor may suffer on account of such termination.

In case of any violation / breach of Terms and Conditions of the contract, Corporation reserves the right to terminate the contract with one Month advance notice besides forfeiture of Security Deposit and Bank Guarantee amount.

34. The Advertising Contractor shall not employ, associate or include as business partner with any person who was advertising contractor of the Corporation and defaulted in payment of contract amount.

In case it comes to the notice of the Corporation that the Advertising Contractor has employed / associated / included such person in carrying out the business, the Corporation shall have the right to terminate the contract.

35. The business shall be carried out only on the name / firm, as the case may be, that was specified on the Tender form, while submitting the tender. During the course of contract, the Contractor / Agency shall not be allowed to change the name of the Agency or to transfer the Agency.

36. In case of any violation of the conditions of the contract, the Corporation reserves the right to terminate the contract besides forfeiture of deposit.

Signature of the tenderer

- 37. The VC&MD of the Corporation, reserves the right to accept, reject or modify any or all Tenders without assigning any reasons thereof. The tenderer shall have no cause of action or claim against the Corporation or its Officers, employees successor assignee for rejection of his/her tender.
- 38. The VC&MD of the Corporation reserves the right to modify any condition/conditions of the agreement, and add any other condition/ conditions during the contract period. The Advertisement contractor has to abide by the conditions modified/incorporated and has to enter into a fresh agreement with the Corporation at his/her/its cost.
- 39. In case of any dispute or differences arising on the Terms and Conditions of the tender or contract as the case may be, the decision of the VC&MD, TGSRTC, shall be final and binding on both the parties.
- 40. If any dispute arises between the Contractor and the Telangana State Road Transport Corporation, the Courts of Hyderabad and Secunderabad shall have jurisdiction.


