TERMS AND CONDITIONS:-

1. Tender Forms can be obtained from the Office of the Superintendent&CMO, Tarnaka, Hyderabad on payment of Rs.2,950/- (Rupees Two Thousand Nine Hundred Fifty only) (i.e..Rs.2,500/- cost of Tender Form + Rs.450/- GST @ 18%) in between 09.30 AM and 04.00 PM on Saturdays from 09.30 AM to 01.30 PM from **24-08-2024 to 02-09-2024**, money receipt obtained from AO office, Tarnaka, Hyderabad. The cost of application once paid will not be refunded under any circumstances.
2. Minimum value of the contract includes PF, ESI, EDLIF, off relievers, 7% profit margin and GST &18%.
3. The detailed terms and conditions relating to the above mentioned work contract will be supplied along with the Tender Form.
4. TGSRTC reserves the right to cancel or reject any or all the tenders without assigning any reasons thereof.
5. The Superintendent&CMO, TGSRTC Hospital, Tarnaka reserves the right to reject the issue of tender schedule and also to reject for tender schedules without assigning any reason whatsoever.
6. Conditional Tender will not be accepted.
7. The agency should have valid labour license renewed up to date.
8. The EMD is not exempted to any society / voluntary organization / institutions / communities etc.
9. The Contractor shall get registered himself as a labour contractor under the contract labour (Regulation & Abolition) Act, 1970. The contract copies of the following certificates / proof with the Tender Form.
 - (a) Valid Labour license, Electrical “A” Grade Licence with current validity issued by T.S. State Licensing Board, (b) Registration Certificate issued by the Labour Department, (c) PF Code Number, (d) ESI Code number, (e) PAN Card, (f) GST registration.
10. The contractor should submit the following documents with relevant proofs along with the application form for issuing the tender bid.
 - a. Proof of minimum (5) FIVE years experience in maintenance and operation of similar nature of electrical HT & LT installation of major structures such as multistoried buildings, industries, hospital buildings etc. The agency has to submit the relevant experience certificates along with the application form.
 - b. The contractor should have experience in fault findings and attending minor repairs of transformers, OCBs and HT Sub-Station equipment.
11. Finalization of Tenders will be by way of negotiations by the Tender Committee with each of the tenderers and decision of the Tender Committee in this regard shall be final. Other things being equal, **if more than one tenderer quote lowest minimum amount Rs.1,62,654/-** (Rupees One Lakh Sixty Two Thousand Six Hundred Fifty Four only) monthly remuneration / license fee and found suitable by the Tender Committee **the contract shall be allotted on the basis of LOTTERY.**
12. No one presently on rolls of TGSRTC should be employed either directly or indirectly as partner by the applicant.
13. The agency should have a local office in Hyderabad.
