i) Length of Experience(No. of Years):

The eligible bidder should have been working in the field of extending similar services for a period not less than Three (3) years. The Bidder shall submit the details of such services where rendered, as per the Formats provided in the Tender Document.

ii) Financial Criteria:

The Minimum average annual turnover of the Bidders in the form of Gross Revenue should not be less than Rs.75.00 lakhs averaged during the last Three (3) years ending 31st March 2024. The Bidder shall submit the copies of the audited Financial Statements as per the formats provided in the Tender Document.

iii) Trade permissions:

The agency should be in possession of valid Trade business license (Tent House Supply materials) (Issued by local bodies), TIN Number, GST and shall submit IT clearance certificate also.

TGSRTC reserves the right to cancel, Split up and award/postpone/reject any or all the tenders in part or full without assigning any reason whatsoever. No correspondence will be entertained in this regard. Any claim by any tenderer in regard to their investment in submission of their tenders will not be entertained.

5. License Fee:

The agency is required to pay License Fees in the form of (a) Rent on the allotted built up space for keeping the materials and (b) Permission Fee per Function as fixed by the Department.
