7. The bidder shall authenticate the tender with his digital certificate(key) for submitting the tender Electronically online platform and the bids not authenticated by digital certificate(key) of the bidder will not accepted on the online platform.
8. Bidder shall submit Price Bid online only. The basis price should be excluding GST and other taxes Applicable if any.
9. The bidder shall sign on each page of tender form including general terms & conditions, Annexure -I,II,III & IV.
10. Online tenders will be opened on 24.08.2024 at 11.00 hours by a committee in the presence of the bidders or their authorized representatives.
11. The successful bidder must deposit six highest monthly license fee + one month advance license fee and stamp duty @ 2% on average annual license fee for execution of agreement before commencement of business.
12. The successful bidder shall pay the GST as applicable from time to time (at present the GST is 18% CGST 9% + SGST 9%) on payment of monthly license fee(quoted by the licensee) every month.
13. The successful bidder shall pay the Maintenance Charges @Rs.1.50 per sft(maximum Rs.4,000/-) for every month.
14. The licensee has to fix the Surveillance Cameras in the Stall as specified by the police department.
15. TSRTC reserves the right to accept or reject the tender of any stall or stalls at the sole discretion TSRTC without assigning any reasons thereof.
