8. Bidder shall submit Price Bid online only. The basic price should be excluding GST and other taxes applicable, if any.
9. Tender forms (i.e., downloaded hardcopies, EMD DD and Tender processing fee DD) kept in sealed cover by mentioning Stall No, the nature of the business and name of the Bus Station written in capital letters on top of the cover shall be dropped in the Tender Box kept at Office of the Regional Manager, MGBS 1st floor, Hyderabad Region during the office hours **from 10.30 to 14.00 hours on 09.09.2024.**
10. The bidder shall sign on each page of tender form including general terms & conditions, Annexure-I,II,III & IV.
11. Online tenders will be **opened on 09.09.2024 at 15.00 hours** by a committee in the presence of the bidders or their authorized representatives.
12. The successful bidder must deposit six highest monthly license fee + one month advance license fee and stamp duty @ 2% on average annual license fee for execution of agreement before commencement of business.
13. The successful bidder shall pay the GST as applicable from time to time (at present the GST is 18% CGST-9% + SGST-9%) on payment of monthly license fee (quoted by the licensee) every month.
14. The successful bidder shall pay the Maintenance Charges @ Rs.1.50 per sft (maximum: Rs.4,000/-) for every month.
15. The licensee has to fix the Surveillance Cameras in the stall as specified by the police department.

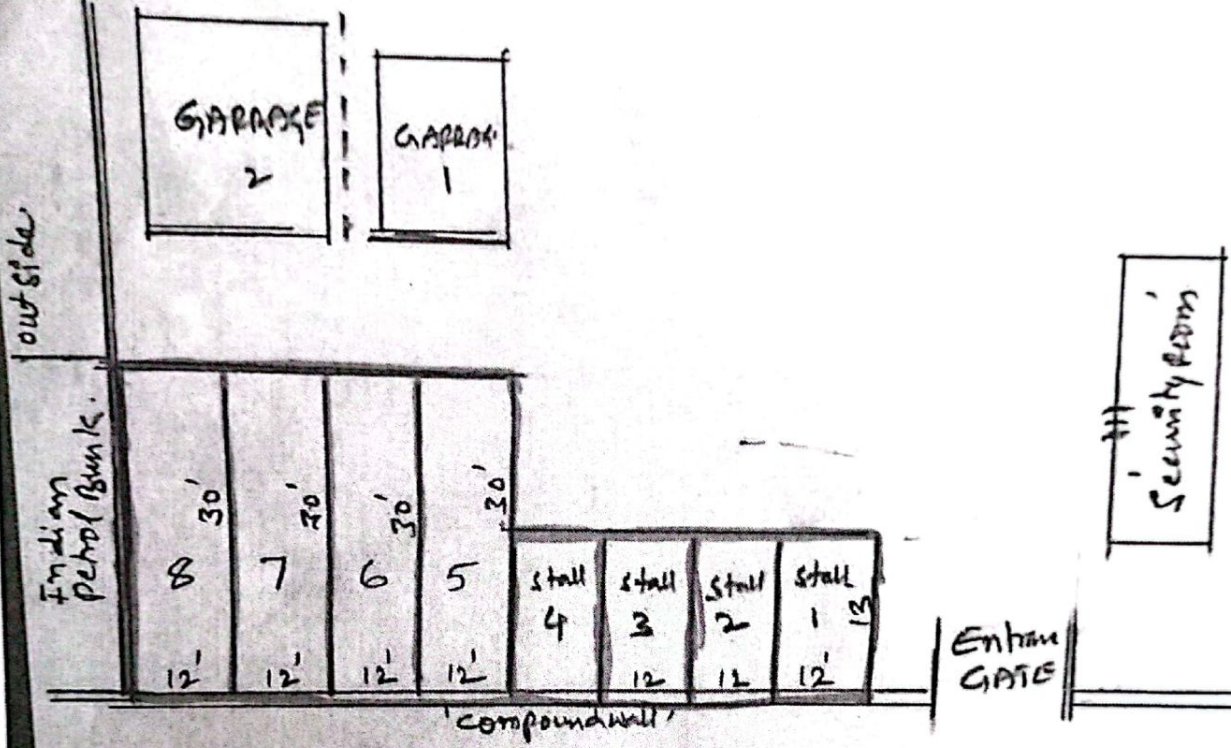
